These are a temporary set of measures which sit alongside the latest version RA 029 School -National Lockdown V8 07/01/21.

Early years providers are required to stay open and allow children to attend their normal timetabled hours. This includes early years registered nurseries and childminders, maintained nursery schools, nursery classes in schools and other pre-reception provision on school sites. Children in reception should only attend education or childcare if they are a vulnerable child or at least one parent or carer is a critical worker.

All nurseries and childminders are open to young children.

Nurseries are required to :

- manage confirmed cases of coronavirus (COVID-19) in the nursery in line with current public health guidance - this means your child may be asked to self-isolate for 10 days from the day after contact with the individual who tested positive by their nursery, childminder, school or college (based on advice from the PHE advice service or local health protection teams) if they have been in close, face-to-face contact with someone who has tested positive for the virus
- ensure that everyone cleans their hands more often than usual, including when they arrive, when they return from breaks, and before and after eating - this should be done for 20 seconds with soap and running water or hand sanitiser
- promote the 'catch it, bin it, kill it' approach, to ensure good respiratory hygiene
- enhance cleaning and ventilation, including cleaning frequently touched surfaces more often

Nurseries will also minimise contact between groups of children where they can. This could mean using different rooms for different age groups and keeping those groups apart.

Background

The DfE has published [actions for early years and childcare providers during the coronavirus \(COVID 19 \) outbreak.](#)

Nurseries should continue to review their full opening of school risk assessments and implement the system of controls set out in this guidance.

These measures provide a framework for school/setting leaders to put in place proportionate protective measures for children and staff. If settings follow the guidance and maximise control measures, they can be confident they are managing risk effectively.

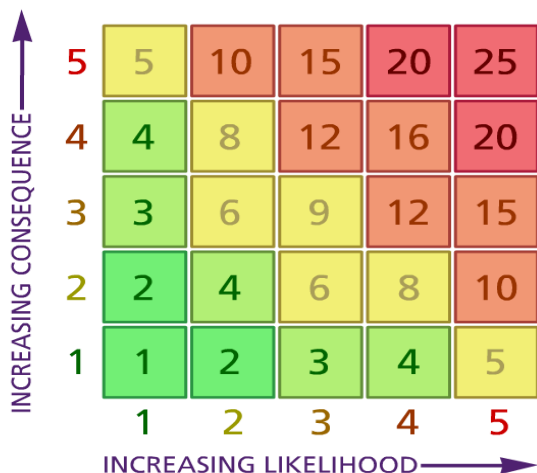

It is not mandatory for staff and visitors to wear face coverings. Cleaning – lack of cleaning leading to increasing the risk of transmission	Staff, pupils, parents, visitors increased risk of transmission of Coronavirus (COVID 19)	<ul style="list-style-type: none"> Enhanced cleaning regime in place for all equipment and resources Staff have their own items that are not shared. Resources, such as books, toys and equipment, are used and shared within groups but these are cleaned regularly, along with all frequently touched surfaces. Resources that are shared between groups, such as sports and art equipment are cleaned frequently and carefully between different group use or rotated to allow them to be left unused and out of reach for a period of 48 hours (72 hours for plastics) between use by different groups. Outdoor playground equipment is cleaned more frequently. Resources used inside and outside by wraparound care providers are subject to enhanced frequent cleaning. Parents are asked to limit the number of personal belongings children bring into setting each day, to essentials such as lunch boxes, hats, coats, and books. Visitors to the setting Settings leading to increasing the risk of transmission	Staff, pupils, parents, visitors increased risk of transmission of Coronavirus (COVID 19)	<ul style="list-style-type: none"> The setting/nursery will restrict all visits to the setting to those that are necessary. Visits that allow a vulnerable child to meet a social worker, key worker or other necessary support continue on site. Visits for SEND therapies continue on site. Parents may continue to settle new children. The setting will continue to take new admissions in line with current guidance. Visits from parents can take place if they are necessary using zoom or Microsoft teams. We will work with parents to ensure parents still have visibility of the childcare environment during this time, including through the use of remote visits, pictures and phone calls. 	3X2=6	
Supply teachers and other temporary staff increased risk of transmission	Staff, pupils, parents, visitors increased risk of transmission of Coronavirus (COVID 19)	<ul style="list-style-type: none"> Settings can continue to engage, students, volunteers and other supply staff during this period of national lockdown. Supply staff and other temporary staff can move between settings. They should ensure they minimise contact and maintain as much distance as possible from other staff. Specialists, therapists, clinicians and other support staff for children with SEND can provide interventions as usual. See RA 029 School opening -National Lockdown v8 for measures to reduce the risk of other visitors to the site, such as contractors, visitors, catering staff and deliveries & contract cleaning staff 	3X2=6	
Music, dance and drama increased risk of transmission	Staff, pupils, parents, visitors increased risk of transmission of Coronavirus (COVID 19)	<ul style="list-style-type: none"> Nursery/the setting has the flexibility to decide how organised sessions for music, dance and drama will be provided to children attending the setting while following the measures in the system of controls. All performances with an audience have ceased. 	3X2=6	SEE WHOLE SCHOOL RA – Currently visits from peripatetic teachers are suspended

		<ul style="list-style-type: none"> • See RA 029 School opening -National Lockdown v8 for full measures to reduce the risk from singing & music activities. • Peripatetic teachers can move between settings, but will be controlled alongside other visitors to the setting. • Individual one-to-one lessons in the setting should only take place with staff based at the setting or be undertaken online with teachers from outside the setting 		
Attending more than one setting increasing the risk of transmission	Staff, pupils, parents, visitors increased risk of transmission of Coronavirus (COVID 19)	<ul style="list-style-type: none"> • We recognise there may be situations where a child needs to attend more than one setting. • We encourage parents and carers to limit the number of settings their child attends, ideally ensuring their child only attends the same setting consistently. • Where a child must routinely attend more than one setting on a part time basis we will conduct an individual risk assessment for that child. 	3X2=6	SEE WHOLE SCHOOL RA
<u>Clinically extremely vulnerable</u> Children at increased risk of contracting COVID 19	Staff, pupils, parents, visitors increased risk of transmission of Coronavirus (COVID 19)	<ul style="list-style-type: none"> • Shielding advice is currently in place in Tier 4, so all children still deemed clinically extremely vulnerable are advised not to attend school. • Children who live with someone who is clinically extremely vulnerable, but who are not clinically extremely vulnerable themselves, should still attend education or childcare. • Parents of clinically extremely vulnerable children will be receiving a letter shortly confirming this advice. 	3X2=6	
Clinically extremely vulnerable Staff at increased risk of contracting Covid 19 Employees who have been identified as <u>clinically extremely vulnerable</u> . <p><u>Pregnant employees</u> at increased risk of contracting COVID 19</p> <p>Pregnant women are considered 'clinically vulnerable' or in some cases 'clinically extremely vulnerable' to coronavirus (COVID-19) and therefore require special consideration as set out in the <u>guidance for pregnant employees</u>.</p>	<p>Staff, pupils, parents, visitors increased risk of transmission of Coronavirus (COVID 19)</p>	<ul style="list-style-type: none"> • School will carry out a risk assessment to follow the Management of Health and Safety at Work Regulations 1999 (MHSW). See RA 009 New & expectant mother v5 Jan 2021 risk assessment. As part of their risk assessment school will consider whether adapting duties and/or facilitating home working may be appropriate to mitigate risks. • The risk assessment will support the employee to continue working • Women who are 28 weeks pregnant and beyond or are pregnant and have an underlying health condition that puts them at a greater risk of severe illness from COVID-19 at any gestation, should take a more precautionary approach. • School will ensure pregnant staff are able to adhere to any active national guidance on social distancing and/or advice for pregnant women considered to be clinically extremely vulnerable. <p>Pregnant women are not advised to be vaccinated against COVID-19.</p>	<p>3X2=6</p>

Risk Rating	Action Required
17 - 25	Unacceptable – stop activity and make immediate improvements
10 – 16	Tolerable – but look to improve within specified timescale
5 – 9	Adequate – but look to improve at review
1 – 4	Acceptable – no further action but ensure controls are maintained
